

Westlaw Dockets Coverage


Dockets information is available in Dockets databases on Westlaw and from Westlaw Court Express.

- Dockets databases on Westlaw enable you to access case docket information without having to leave your office or contact court staff.
- Westlaw Court Express (available at courtpress.westlaw.com) is a custom-designed research tool for docket searching. It includes easy-to-use templates and other docket research features.

This guide lists dockets coverage on Westlaw and online from Westlaw Court Express. (When documents are not available electronically, or if you need a hard copy, Westlaw Court Express also offers delivery from any court in the U.S or around the world.) Online dockets coverage information includes the following:

 = In jurisdictions that are shaded, you can link from a dockets document to related information on Westlaw. Linked materials include associated case law, court rules, statutes, briefs, trial documents, attorney and judge profiles, and litigation history reports.

- **Dockets Coverage:** Know whether dockets are received from the court, uploaded to Westlaw, and updated with new docket proceedings. Update frequency varies by court.
- **Court Wire Coverage:** Know whether pre-dockets are received from the court the same day and uploaded to Westlaw within minutes. Court Wire alerts are available for continuous delivery throughout the day.
- **Docket Alerts:** Search court dockets for new case filings that meet your search criteria.
- **Docket Tracks:** Monitor additions to the docket for a specified case.
- **Court Express Find by Case Number:** In Westlaw Court Express, find a docket when you know the court docket number for a specific case. When available, this feature retrieves real-time any docket that is electronically available from the court.
- **Terms and Connectors Search Coverage:** As an alternative to templates, search using the Terms and Connectors search method. The listed date range represents the period during which dockets are indexed for retrieval by this method. For retrieving dockets outside this date range, a search template or the court docket number must be used.
- **Included in DOCK-ALL:** Know whether dockets are available for the court in the Dockets-State and Federal Courts Combined (DOCK-ALL) database on Westlaw.
- **Criminal Dockets:** Know whether criminal dockets are available for the court. (Civil dockets are available for all courts with available dockets.)
- **Other:** Know whether other dockets are available for the court, such as probate, domestic, small claims, or tax court dockets. (If no other dockets are indicated, other dockets may still be available.)
